



## ACCIDENT WAIVER AND RELEASE OF LIABILITY

I, \_\_\_\_\_, HEREBY ASSUME ALL OF THE RISKS OF PARTICIPATING AND/OR VOLUNTEERING at His Oaks Ministry, all EVENTS and ACTIVITIES, including by way of example and not limitation, any risks that may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained, or controlled by them, or because of their possible liability without fault.

I certify that I am physically fit, have sufficiently prepared or trained for participation in the activity or event, and have not been advised to not participate by a qualified medical professional. I certify that there are no health-related reasons or problems, which preclude my participation in His Oaks Ministry and the activities and events that it may involve.

Staff and Volunteers of His Oaks Ministry, unless otherwise indicated, are not licensed counselors, but will engage in life coaching and mentoring through Biblical Teaching.

I acknowledge that this Accident Waiver and Release of Liability will be used by the event holders, sponsors, and organizers of the Ministry and its activities and/or events in which I may participate, and that it will govern my actions and responsibilities at said activities or events. In consideration of my application and permitting me to participate in this Ministry, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows:

(A) I WAIVE, RELEASE, AND DISCHARGE from any and all liability, including but not limited to, liability arising from the negligence or fault of the entities or persons released, for my death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to me including my traveling to and from this ministry, THE FOLLOWING ENTITIES OR PERSONS: The Board of Directors, Their Families, The Founder, The Managing Staff, Volunteer Staff, or other individuals participating in the Ministry.

(B) I INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in this Ministry and its correlating activities and events, whether caused by the negligence of release or otherwise.

I acknowledge that His Oaks Ministry and their directors, officers, volunteers, representatives, and agents are NOT responsible for the errors, omissions, acts, or failures to act of any party or entity conducting a specific event or activity on behalf of the His Oaks Ministry. I acknowledge that this Ministry and its associated activities and events may involve a test of a person's physical and mental limits and may carry with it the potential for death, serious injury, and property loss. The risks may include, but are not limited to, those caused by terrain, facilities, temperature, weather, condition of participants, equipment, vehicular traffic, actions of other people including, but not limited to, participants, volunteers, spectators, coaches, event officials, and event monitors, and/or producers of the event(s), and lack of hydration. These risks are not only inherent to participants, but are also present for volunteers.

I hereby consent to receive medical treatment, which may be deemed advisable in the event of injury, accident, and/or illness during this activity or event. I understand that at this Ministry and correlating events or related activities, I may be photographed. I agree to allow my photo, video, or film likeness to be used for any legitimate purpose by the event holders, producers, sponsors, organizers, and assigns. The accident waiver and release of liability shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.

I CERTIFY THAT I HAVE READ THIS DOCUMENT, AND I FULLY UNDERSTAND ITS CONTENT. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT AND I SIGN IT OF MY OWN FREE WILL.
